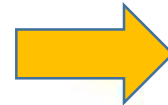

Youth - Teenagers - Women

Single or couple women  
Mothers deprived of their liberty  
(mental hospital - Prison)



Trauma, pain, unreal mourning,  
a difficult recovery

. Obstetric Violence  
. System Violence

- . They were told that their babies were stillborn.
- . They never handed over the body
- . There are no certificates or public document that proves death

*When doubting many mothers began their search*

## RECOMMENDATIONS



**Implementation period** - until the next UPR report,

1. **That it be included in the National Budget** – including modernization of the BNDG and cross-linking with other public laboratories
2. **That an Inter-Ministerial Commission be formed for this issue** – Ministry of Justice, of Women and Diversity, Ministry of Security and Ministry of Health.
3. **Amend the existing law and incorporate the Law of biological mothers.**
4. **That Conventionality Control be applied, from restorative justice, transnational, with a gender perspective.**
5. That awareness campaigns be carried out.
