Situation in NIGERIA – Issue 1

Civilian protection & Accountability for Abuses

Nigeria supported several recommendations at its 3rd UPR to ensure the protection of civilians and accountability for abuses but continues to fall short in this area.

Citizens are experiencing heightened insecurity in regions of the country including:
Northwest - Banditry crisis
Northeast - Ongoing Boko Haram conflict

Southeast - Anti government groups clamoring for secession

- > Authorities are failing to investigate and hold perpetrators accountable.
- Security forces in responding to the insecurity also continue to be implicated in gross human rights abuses without accountability.

Recommendations – Issue 1

- Deploy adequate security measures and personnel to protect vulnerable communities from attacks.
- Carry out prompt investigation of attacks against civilians and bring those responsible to justice .
- Address fair trial concerns and resume trials of Boko Haram suspects.
- Provide details and move forward with the announced investigation into accidental airstrikes by the Nigerian Airforce.
- Adopt strong monitoring and assessment processes to mandate compliance with international human rights principles and standards in military operations.

Situation in Nigeria – Issue 2

Internally Displaced Persons (IDPs) Rights

- Some efforts taken towards recommendations during the 3rd UPR for Nigeria to adopt measures to protect IDPs including women & children but others have undermined this.
- Nigeria adopted National IDP Policy in 2021.
- Between 2021 and 2022, authorities in Borno state, the epi center of the Boko Haram conflict with over about 1.9 million IDPs, arbitrarily shut down camps for internally displaced persons.
- The camp shutdowns cut thousands from aid and pushed them deeper into suffering &vulnerability.

Recommendations – Issue 2

- Halt further camp closures until adequate alternatives are available to displaced people.
- Work with relevant state authorities and the humanitarian community to explore and provide durable solutions for displaced people in line with applicable international standards.

Situation in Nigeria – Issue 3

Economic & Social Rights

- Several recommendations during the 3rd UPR for the government to take steps to strengthen social protection and improve living conditions for its citizens.
- > Welcome efforts by the Federal government to adopt a Social Protection Policy.
- Currently about 133 million people in the country live in multidimensional poverty with high levels of deprivation in areas including:
- sanitation
- health care
- food
- housing.
- Despite this situation, there remains no functioning social security system to support citizens in these areas.

Recommendations – Issue 3

- Draft and support legislation that recognizes Nigerians' right to social security and other economic and social rights.
- Develop a national strategy to fulfill the right to social security, building on the federal government's existing social protection policy.
- Review and harmonize existing domestic laws and policies with regional and international law standards on the right to an adequate standard of living, which encompasses adequate food, water, and housing.
