Oktavianus was shot in the left knee and in the lower abdomen in order to force him to confess to theft of firearms. Caban was shot in both knees and chest. Caban died on 29 th July 2014 as a result of his injuries. | Violence broke out between security forces and armed members of the TPN/OPM in Puncak Jaya in January. Note: Oktovianus Tabuni is not able to return home to Pirime and is believe to be hiding in Papua New Guinea. Paulus tried to prevent the police from getting into his house by standing in the front door. The Brimob personnel then attacked Paulus stabbinghim five times in the back and slashing him about the head with a knife.
