- 1. As we indicated in our concluding Statement to the Working Group on the occasion of the Universal Periodic Review of Barbados in January 2013, Barbados remains steadfastly committed to the Universal Periodic Review process. We recognise the important role that this process plays in allowing states to examine the human rights situation in their countries and identify ways in which their human rights framework can be strengthened.
- 2. During our review, Barbados received one hundred and fifteen (115) recommendations which ranged from recommendations to ratify twelve additional treaties to recommendations to establish a national human rights institution, fight against discrimination, strengthen mechanisms to prevent domestic violence and provide greater protection to domestic workers and persons with disabilities.
- 3. The Government of Barbados has reviewed the 115 recommendations it received and is pleased to report that Barbados has accepted 71 recommendations either in full or in part. In keeping with emerging practice, we have attached as an annex to this document, a full list of the recommendations received and our responses to these recommendations.
- 4. These responses reflect the position enunciated by Barbados in its national report and statements to the Working Group of the Universal Periodic Review, in January 2013.
