## Consideration of the Universal Periodic Review (UPR)report of the United Kingdom of Great Britain and Northern Ireland

Mr President,

Defence for Children International is delivering this statement together with the Children's Rights Alliance for England, Wales UNCRC Monitoring Group, and Together (Scottish Alliance for Children).<sup>1</sup>

We welcome the report of the Working Group on the UPR of the UK<sup>2</sup>, in particular the recommendations relating to children's rights.

We welcome efforts to improve protection of children's rights, including a child rights duty on Ministers in Scotland and Wales and a child rights 'programme of action' in England; significantly reducing the numbers of children in prison and steps to better protect children from harm.

However, the UK is only supporting 42% of the recommendations received. We urge the UK to reconsider its position and strongly encourage implementation of recommendations concerning:

- Safeguarding of the Human Rights Act<sup>3</sup>
- The ratification of the Third Optional Protocol to the United Nations Convention on the Rights of the Child (CRC)<sup>4</sup>
- The withdrawal of its declaration to Article 1 of the CRC Optional Protocol on the involvement of children in armed conflict<sup>5</sup>

- The incorporation of the UNCRC into domestic law<sup>6</sup>The establishment of coordination and monitoring structures to ensure full CRC implementation<sup>7</sup> and adopting a human rights action plan<sup>8</sup>
- The provision of appropriate legal aid to all children<sup>9</sup>
- The review of anti-terrorism measures<sup>10</sup>
- The training of police on human rights, including on excessive use of force <sup>11</sup>
- The strengthening of measures to combat child trafficking 12
- The increase in efforts to eradicate child poverty<sup>13</sup>
- The non-detention of children for immigration purposes<sup>14</sup>; and the guarantee of family reunification rights for separated children<sup>15</sup>
- The prohibition of all corporal punishment in the family<sup>16</sup>
- The raising of the minimum age of criminal responsibility<sup>17</sup> and the abolition of life sentences for persons under 18 years old<sup>18</sup>

We urge the UK Government and devolved administrations to consult with civil society in UPR follow up.
